I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime \_\_\_\_\_

On Thursday 6/25/2015 at approximately 1956 hours Clinton County Deputies were dispatched to the unincorporated area known as Elvira for a domestic in progress with reports of shots fired. Upon arrival Deputies made contact with victim Jennifer Wiese who is the sister of the defendant, Joshua Wiese. Deputies also observed the defendant outside of a residence, later identified as 3807 220th St., which is the

residence of the defendant, with what appeared to be a long barrel firearm. During a subsequent interview the victim stated the defendant assaulted her while she was in the bathroom by grabbing her by the throat and slamming her head into the wall. The victim states while the defendant grabbed her by the throat he squeezed to the point she had to gasp for air. During the scuffle the victim was able to get the defendant out of the bathroom. The defendant then grabbed a large steak knife, went outside, and attempted to enter the bathroom by removing the window screen. Next the victim stated she ran out of the residence and ran to a neighbors house. During an interview with the victim Deputies observed red marks and abrasions on her neck area consistent with strangulation.


