DEFENDANT

I, the undersigned, state that the following facts known by me or told to me by other reliable persons form the basis for my belief that the Defendant committed the crime(s) of: **Sexual exploitation by a school employee**

On 8/21/15 the defendant initiated private communication with a 17 year old female student who had turned in a paper to him as he was her teacher. Over the course of approximately 2 months the defendant pushed the limits in messages over Facebook. The messages started out with the Defendant identifying the student's vulnerabilities and expressing a concern for her safety and well being. The messages at times were sexual in nature and intended by the Defendant to sexually arouse both parties. He tells the student 'I'm going to cross over to the creeper side a moment and tell you. You are hot.' He subsequently tells her 'I see in you what I want in a women' and tells of his infatuation towards her. He also tells her what he describes as "pervy stuff" and complements her on her 'booty', legs, and curves. He subsequently comments to her about her chest and that her body is perfect.

Over the course of 600 pages of facebook messages the defendant continued to groom the victim for sexual conduct and push the limits of the conversation. The facebook conversations sometimes lasted into the early morning hours. On one occasion after the student told him she needed to go to sleep the Defendant stated 'I'm leaving you unsatisfied or wanting more. ... That was dirty sorry.' When the student commented that she would be alone after their messaging ended, the Defendant stated 'No your never alone and your going to go to sleep with me.'

The Defendant sometimes messaged about meeting privately. On one occasion he told her directions to his home. On another occasion the defendant set up a meeting with her where they met at Wal-Mart and he hugged her in the parking lot. Review of the facebook communication revealed pictures of the Defendant hugging the student on other occasions. The defendant talks in the messages over Facebook of a "dry spell" meaning lack of sexual activity. The victim admits that the messages were to her sexting.

On 10/4/15 at 2310 hrs, the defendant states to the victim in a message on Facebook. "Do you really think you'd like to take this farther despite the age? Could you really be happy with a guy that is 36 divorced with 3 kids"? When asked in an interview the victim stated that she felt the defendant wanted to have a sexual relationship with her.

The Defendant at times engages in conversation about how he would be in trouble if they were found out. He mentions a need to sneak and hug but mentions the consequence of criminal charges. On another occasion he states 'So I totally freaked out today. . . . saw one of the cops in the building then you called to the office. . . . Thought ut ohhh think I'm dead lol.'

The Defendant at times comments about being able to openly be together in the future after the student's graduation. He encourages her to move out of her parents home by stating 'I'd buy you an apartment and be your sugar daddy lol, if I could afford it. You deserve to feel comfortable. Hugs to you.'

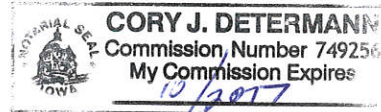
The defendant is a 36 year old licensed teacher at Camanche High School and the victim is a 17 year old student at Camanche High School.
